### **State Board Rules and Regulations Debrief**

It was made clear at the meeting of the State Board that minor grammatical, phrasing and changes for clarification could be made without incurring a new 45 day public comment phase. The State Board made several minor modifications to the rules for clarity in response to public comments that had been submitted during the 45 day comment period. Also several areas within the rules were tabled for future modification after more consideration.

#### **New Business**

#### **Workers Compensation**

Currently there is no language in the Workers Compensation rules to include Acupuncture providers as approved providers. *Carrie Guschewsky will begin contact with Wyoming Workers Compensation* to determine who we approach to implement the addition of Licensed Acupuncturist as approved providers in Wyoming.

Alisha stressed the importance of getting this started as soon as possible to allow our newly licensed practitioners get this access in 2018.

The Board will survey the membership to see where the interest lies with continuing education interest. Possible for the Spring meeting, would be a weekend including WAS meeting, and following CEU options:

Alisha will speak with Kate Johnston about avenues to increase public awareness of WAS, possibly putting content in regional medical publications, TV etc. Traci will be in charge of developing monthly practitioner profiles on facebook and website.
